

2007 MODEL SUPERVISOR AWARD

ROSEMARY LOMBARDI, CVT, Head Nursing Supervisor for the Matthew J. Ryan Veterinary Hospital, School of Veterinary Medicine

Ms. Lombardi, a Certified Veterinary Technician, arrived at Penn in 1991 and rose through the ranks to her current position. She supervises 20 nurses and five nursing assistants and helps mentor new supervisors in the Nursing Department. In her role as supervisor of the Vet Hospital's Intensive Care Unit, Ms. Lombardi is responsible for scheduling and managing operations that run 24 hours a day, 7 days a week. Her staff report:

JOANN DESIDERIO, Director of Delivery and Operations, Wharton Executive Education, The Wharton School

Ms. Desiderio came to Wharton in 1996 and rose through the ranks to her current role. Joann is responsible for 34 staff members, 18 as direct reports. Together, they implement approximately 225 executive education programs involving around 8,000 participants a year.

Her staff tells us: "[Joann] treats everyone with respect, grace and intelligence... She handles difficult situations with diplomacy, integrity and optimism."



PAMELA LAMPITT, General Manager, Conference Services, Business Services Division

Ms. Lampitt began her career at Penn in 1981 in Dining Services and moved to Conference Services in 2002 for this role. She supervises six staff members and during the summer months, oversees an additional six full-time staff and 40 students. She is responsible for planning and implementing conference, event, and visitor services for campus conferences as well as for many of the summer activities at Penn.

Her staff tells us: "Pam has a talent for motivating members of her staff to perform at their best. She is supportive and instills a team spirit with authenticity and verve."
